The Korean Prosecutors Association (KPA) is proud to announce the second KPA Scholarships for Criminal Justice to law students in Southern California. The KPA Scholarships are provided by the KPA Justice Foundation and are intended to assist law students who envision sharing the mission of KPA during their future careers as public prosecutors.

On September 22, 2018, the KPA will award scholarships of \$1,000.00 each to five deserving law students.

In order to be eligible for these scholarships, you must be:

- 1) Enrolled and attending a law school in the Fall 2018 semester;
- 2) A member of KPA (applications may be submitted simultaneously with scholarship applications and can be found online at www.koreanpa.com);
- 3) Current or former law clerk with a prosecuting agency; and
- 4) Personally present at the dinner on September 22, 2018, in Los Angeles, CA.

A scholarship application must include the following items:

- a. A completed and signed application form;
- b. A written verification of enrollment and attendance from your law school;
- b. Your current resume; and

- c. A personal statement of no more than three pages, double-spaced, describing your interest in, commitment to, and any plans for a career in criminal prosecution, as well as your interest and involvement in the Asian American Pacific Islander community. Please highlight why you want to be a prosecutor as well as instances where you have assisted the Asian-American community.
- d. Letters of reference and any other supporting materials are optional; they may be considered at the KPA's discretion.
